# General development plan (PAG)

The general development plan (PAG) is a set of mutually complementary graphic and written regulations covering the entire municipal area and dividing it into different zones whose land use they define.

The aim of the general development plan is the reasonable distribution and location of human activities in the various areas it defines, thus ensuring the sustainable development of the municipality, based on the objectives set out in Article 2 of the amended Act of 19 July 2004 on Municipal Spatial Planning and Urban Development.

Each municipality is required to have a general development plan covering its entire territory. Two or more municipalities may join together to prepare a joint project that replacing a general development plan for each municipality.

# Special development plan (PAP)

A special development plan (PAP) covers a part of the municipal territory, urbanised or intended to be urbanised, by implementing and specifying the PAG to which it refers, while respecting the type and degree of land use established therein. It contains a set of urban planning regulations in compliance with the objectives of Article 2 of the amended Act of 19 July 2004 on Municipal Spatial Planning and Urban Development (sustainability, harmonious development of neighbourhoods, quality of life of residents, ...).

There are two types of PAPs:

- The PAP NQ "New district"
   (nouveau quartier), which
   covers an area earmarked for
   urbanisation and proposes a
   concrete urbanisation project and
   defines the shape of the public
   space, the building plots, and
   the future constructions. It must
   include a written and a graphic
   part and be accompanied by a
   justification report.
- The PAP QE "Existing neighbourhood" (quartier existant), which covers a fully developed area and sets the rules for the integration of buildings according to the characteristics of the existing building fabric. It must be prepared on the initiative of the municipality and adopted in parallel with the PAG when it is first drawn up, as well as containing a written section.

## New construction(s), renovation(s), conversion(s)

#### Application for a building permit

Construction, renovation, and conversion work on buildings (see the complete list in Article 61 of the Ordinance on Buildings, Public Roads and Sites, p. 51) must be approved in advance by the mayor. It is forbidden to start work without having obtained this authorisation. Every project must comply with the municipality's general development plan and, if applicable, the special development plan, as well as with the various relevant municipal ordinances.

Furthermore, a building permit can only be issued against receipt of the fees due according to the applicable fee schedules.

#### When is a declaration of works sufficient?

Some works do not require a building permit. It is sufficient to submit a "declaration of works" (déclaration de travaux). These are:

- · major maintenance work carried out on existing buildings. including the replacement of
- · scaffolding located on private property.
- · installations and conversions of natural gas-fired heating systems,
- · any installation of solar panels.

The declaration of works must be submitted at least 10 days before the start of the work.

## Connection to various networks and underground utilities

All technical installations necessary for the supply of energy and heating, all heating, air-conditioning, lighting and telecommunication installations. all fireplaces, ovens, boiler rooms, all flues, gas extractors and similar installations, all lifts, goods lifts and their shafts must be constructed in each of their parts in accordance with the applicable legal provisions and ordinances that exist in this regard.

Lines and pipes for the supply of drinking water, electricity and other goods, sewers and all necessary connections to collective networks must be laid underground.

All technical installations that are necessary for the power supply must be earthed in accordance with the applicable legal provisions and regulations. Drinking water pipes must not be used for these purposes.

#### Drinking water

Without prejudice to any other applicable laws and regulations in force in this area, any building with rooms intended for prolonged occupancy must be connected to the main water supply network.

The supply of drinking water from wells is prohibited.

All pipes and connections must be laid underground, be at a frost-proof depth (minimum 0.80 m) and be installed in all parts in accordance with the applicable legal provisions and regulations that exist in this area.

A building permit will only be granted if this connection is possible.

The water comes from the Syndicat des Eaux du Sud network up to the supply point, which consists of the municipal water reservoirs. From the Rebierg water tower (SES), the water consists on the one hand of spring water from the SES and on the other hand of treated surface water (water from the Esch-Sauer reservoir via a distribution network of the inter-municipal syndicate SEBES).

As soon as the construction work begins, a temporary water meter will be installed by the Technical Department - Control Service (service de régie).

The water used for the construction site is thus invoiced

#### Sewerage, wastewater

Without prejudice to any other applicable laws and regulations in force in this area, connection to the existing collective sewerage network is compulsory for:

- all buildings housing rooms for the prolonged stay of persons,
- all sanitary facilities,
- all sealed surfaces with a similar coating,
- all swimming pools with chemically treated water and all undeveloped land within the settlement area on which standing water or mire forms.

All pipes and connections must be laid underground, be at a frost-proof depth (at least 0.80 m) and be installed in each of their parts in accordance with the applicable laws and regulations existant in this area.

It is prohibited to install wells and septic pits.

# Final acceptance of your construction site

At the end of the work, it is necessary to carry out a final acceptance. For this purpose, the completion of the work must be reported to the Technical Department - Permits Service. This can be done using the form "Avis de fin des travaux" (notice of completion of works), which can be downloaded from the website.

Caution! Regarding new buildings: In order to be able to report your arrival in the Municipality of Steinfort, it is essential that you carry out the final acceptance of your building site.

# Refund of the security deposit

Once the work has been completed, you can ask for a refund of the security deposit you paid to the municipal treasury as a guarantee claim for the restoration of any damage to the road infrastructure (road-parking lot-pavement).

This guarantee fee will be refunded after the execution of the external works, entrance, cladding of the garage slope, backfill - excavation, fence walls, etc., minus the damages detected by the Technical Department - Approval Service (service autorisations).

#### Relocation

To prepare your move as well as possible, it is advisable to consult our "Checklist"

Furthermore, private persons as well as companies wishing to reserve parking spaces, use pavements, place rubbish bins, erect scaffolding or simply keep driveways clear due to a move, must be in possession of a permit issued by the Municipality of Steinfort.

The application is without prejudice to any other permits that may be required for the execution of the work.

The form "Demande pour un règlement temporaire de circulation" (Application for a temporary traffic regulation), which can be downloaded from our website, must be duly completed and submitted to the Municipality of Steinfort at least 8 working days before the start of the works

#### Subsidies

The Municipality of Steinfort grants - upon application and submission of the required receipts - the following subsidies:

- application for construction and housing subsidies
- purchase of energy-saving household appliances and the repair of household appliances
- installation of circulating pumps for heating systems
- installation of technical equipment that uses renewable energy, in accordance with the applicable standards and criteria for receiving a state subsidy
- installation of a system for the collection and subsequent use of rainwater in accordance with the applicable standards and criteria for receiving a state subsidy
- purchase of regular bicycles or pedal assisted bicycles
- planting of tall and mediumstemmed trees
