The conditions for the grant state as follows:

Documents to be attached:

1. Paid invoice
2. Certificate from the supplier certifying the conformity of the equipment
3. Certificate of first equipment and/or certificate of disposal of an existing appliance
4. Proof of the energy efficiency class of the appliance or certificate proving the energy efficiency index EEI < 0.18 of the new pump

The subsidy is granted once per household, every 10 years, for the same type of appliance. For household appliances, a subsidy for a new appliance can be granted either for a fridge and freezer or for a combined appliance within the 10-year period. A subsidy can only be granted for an appliance with the highest energy class available on the market at the time of purchase (see list oekotopten.lu). In the case of a repair of an appliance, the number of subsidies is not limited.

For a circulation pump, subsidies can be granted in the case of hydraulic balancing in combination with the replacement of the heating circulation pump by a highly energy-efficient pump (EEI < 0.18, see list oekotopten.lu). This subsidy is only valid for already existing houses and not for new buildings.

The grant is subject to repayment if it has been obtained as a result of false declarations or inaccurate information.

Grants are awarded for acquisitions made and equipment installed from 1st January 2022.

Applications must be sent to the municipal administration within a period of six months of the supply of the product or installation of the equipment.

The administration reserves the right to request any additional documentation if it deems it necessary in order to verify the compliance with the conditions for the award of the grant.

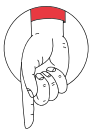
