Subject: School year 2023/2024 - Cycle I (early education)

Dear parents, Dear Madam, Dear Sir,

The College of Burgomasters and Aldermen of the municipality of Steinfort hereby informs you of the possibility of applying for early education for the start of the school year 2023/2024, on 15 September 2023.

Cycle I is an integral part of the Luxembourg school system. It includes early education groups and pre-school classes.

Application to early education is free and attendance is not compulsory. It does, however, give children the opportunity to interact with other children in a playful way. From early childhood, which is a phase of intense development, children should be prepared for a life of independence, discovery and lifelong learning. Through contact with others, children can develop their language, communication and social, physical and motor, emotional and cognitive skills. Early education emphasises play, educational play and language training through practice. Foreign children have the opportunity to improve their Luxembourgish before starting pre-school education.

Admission age

Every child who is 3 years old by 1 September 2023 can be admitted to an early education class.

Timetable and reception

Early Education runs from 8.00 to 11.45 Monday to Friday and from 2.00 to 3.50 pm on Monday, Wednesday and Friday. Arrival time is in the morning is between 7.30 and 9.00 am, and in the afternoon children can come between 1.50 and 2.00 pm. The departure time is between 11.30 and 11.55 am (Monday, Wednesday, Friday) or 12.30 pm (Tuesday and Thursday) in the morning and between 15.50 and 16.00 pm in the afternoon.

For school organisation reasons, we would like to kindly ask you to inform if you would like to enrol your child/children in Cycle I in the municipality of Steinfort **by 31 March 2023 at the latest**. In order to have reliable data regarding the number of children to be enrolled or the number of groups to be planned, **parents who do not wish to register their child are kindly asked to reply via the enclosed registration form. Thank you very much in advance.**

Excerpt from the internal regulations concerning the functioning of cycle 1 groups («preschool "Précoce" education»)

- 1. Children who have reached the age of 3 before 1 September of the school year are eligible for the pre-school cycle.
- 2. Admissions are made at the beginning of the school year, upon declaration by the parents to the local administration (submission of the registration form).
- 3. The enrolment of children is free and optional. Nevertheless, registered children are required to be present regularly.
- 4. The registration of children for a minimum of 5 slots per week is recommended.
- Registration for a minimum of 3 slots per week is compulsory.
- 5. It is desirable that the children are "clean".
- **6.** Children who are enrolled in the first cycle and who live in a municipality other than Steinfort can be admitted to the group with the highest number of free slots.
- 7. Children who are enrolled during the school year will be admitted to the group with the highest number of free slots.
- 8. The difference between the class sizes of the two groups shall not exceed the number of 3 children.
- **9.** All cases not provided for in the present regulation require a decision by the College of Burgomasters and Aldermen on the advice of the School Committee and the Regional Directorate of Basic Education.

Opening hours and admission

Early education operates from 8 am to 11:45 am on Mondays to Fridays and from 2 pm to 3:50 pm on Mondays, Wednesdays and Fridays. Arrival time in the morning is between 7:30 am and 9 am and in the afternoon between 1:50 pm and 2 pm.

Departure time is in the morning between 11:30 am and 11:55 am (Monday, Wednesday, Friday) or 12:30 pm (Tuesday and Thursday), in the afternoon between 3:50 pm and 4 pm.
