Dear parents, Dear Madam, Dear Sir

The College of Burgomasters and Aldermen of the municipality of Steinfort hereby informs you that your child's compulsory schooling will begin on 15 September 2023.

Cycle I (pre-school education) is an integral part of the Luxembourg school system. It includes early education groups and pre-school education classes.

Pre-school education is for children between 4 to 6 years old. It consists of two years and attendance is compulsory for all children who are 4 by the first of September of the current year. The purpose of pre-school education is to contribute to equal opportunities and the acquisition of knowledge and skills. It prepares the child for collective living and learning experiences by aiming at his/her global development, social and school integration. The educational activities stimulate mental, cognitive, language, creative and motor development. One of the main objectives is to learn Luxembourgish.

The law published on 6 February 2009 on compulsory education stipulates that every child is automatically enrolled in a school in the school district of his or her residence. To confirm your child's enrolment in a cycle I class (pre-school) in the municipality of Steinfort

for the school year 2023/2024, please fill in the attached enrolment form and send it back to us by 31 March 2023 at the latest.

The distribution of children to the different school buildings and classes will take place after this deadline. In July 2023, you will be informed of the class your child will attend from 15 September 2023.

If the child is to be enrolled in a school other than the one in the municipality of residence, the parents must inform the Steinfort local authority without any delay and at the latest eight days after the start of the course. You can do so by submitting a copy of the enrolment certificate issued by the school.
