Law of 9 May 2008 on dogs

Art 2

(1) All dogs must be kept on a lead:

- inside built-up areas, subject to paragraph (3) below.
- on public transport, in the communal areas of apartment blocks, in car parks open to the public, at petrol stations and during public events.
- on sports grounds, cycle paths and sports trails.
- (2) In all other places, dog owners are obliged to keep their dogs under control and to keep them on a lead if necessary.
- (3) By way of exception, each municipality may determine, within built-up areas, zones of freedom within which dogs are exempt from being kept on a lead. In these areas, dog owners are also obliged to keep their dogs under control and to use a lead when/if necessary.

 (4) By way of exception, each municipality may also designate areas outside built-up areas that are frequented by large numbers of people and in which dogs must be kept on a lead.

Art. 4

In the event of a change of residence by the dog owner, without prejudice to the provisions of article 3(1), the owner is required to notify the new municipal administration within one month by filling form provided by the latter. The declaration must be accompanied by a valid receipt. The local authority will issue the owner with a new receipt and inform the local authority from which the owner came.

Art. 7

The death or loss, for whatever reason, of a declared dog will not give rise to any remission or reduction of the tax. Dog owners who move to a municipality and can prove that they have paid the tax in the municipality they were living in before will not be taxed in the new municipality of residence until the first of January of the year following the residence's change.
