Regulation

In order for an athlete (m/f) to be eligible, he/ she must meet the following criteria:

A) For individual sports (active members)

- 1. To be domiciled in the municipality of Steinfort or to be a member of a sports club that has deposited its statutes with the municipal administration of Steinfort. All clubs that are members of a member federation of the Luxembourg Olympic and Sports Committee (COSL) are considered as sports clubs.
- 2. To have achieved significant results, i.e. to have achieved, at least, a position in the top three in a national competition or once in the top five in an international competition.

 A national competition is any event organised by a COSL member federation and recognised as such by COSL, thus listed on the official competition schedule of the federation where a ranking has been established.

 An international competition is an official event organised by a member federation of the International Olympic Committee, where a ranking has been established.

Or

3. To have obtained a Luxembourg championship title.

Or

4. To have participated in an official European or world federal competition resp. in an Olympic competition.

B) For team sports

- 1. All clubs which are members of a COSL member federation and which have deposited their statutes with the Steinfort municipal administration are considered to be sports clubs.
- 2. To have successfully moved up to a higher division with one of its teams. The promotion must be the result of sporting results and not the result of a federal decision, for example the creation of new divisions.

Or

3. To have been a finalist in a federal cup.

Or

- **4**. To have obtained, at least, one Luxembourg vice-champion title.
- 5. An athlete who lives in the municipality of Steinfort and is a member of a team from another municipality must have obtained with the team either the title of vice-champion or have been a finalist in a federal cup in the category.

C) For exceptional merit

- 1. Any sports club which is a member of a COSL member federation and which has deposited its statutes with the Steinfort municipal administration may propose licensed members from its ranks who have distinguished themselves by a commitment or by an exemplary gesture.
- 2. Any exceptional sporting achievement or act of fair play by an athlete or sports club (fulfilling the conditions under A1 and B1) may be reported to the Sports and Leisure Commission. The commission will study the proposal and take a decision based on the application.
- **3.** Any proposal of exceptional sporting merit may be considered.

All requests, addressed to the Chairman of the Sports and Leisure Commission, <u>must be accompanied by proof of the results mentioned</u>. The Commission may itself propose sportsmen and women to be honoured and submit its proposals and opinions to the College of Mayors and Aldermen, who will then take the final decision.
